# RIVALS IN LAW

The potentially difficult relationship between a man's mother and wife is explored in the intriguing cooking show "Rivals in Law" as they battle to win his approval in the kitchen. Both prepare the same dish for the man, who faces the unenviable dilemma of declaring his favorite, without knowing who cooked which.

Will it be a chance for the two women to bond and deepen their relationship or will it expose underlying tensions between them? In a reality show with a difference, both have the chance to display their culinary skills and the special man in their lives must make a decision causing joy and dismay in equal measure.

Viewers should be ready for emotional fireworks during the show as the trio share their thoughts and feelings about each other in interviews. Heart-warming stories from the mother about the man's childhood and the wife's accounts of their romance balance any simmering tensions that boil over during the contest.

First, the stars of the show gather to hear the man declare what dish he wants them to prepare. The recipe is prepared by an expert chef and then the mother and wife go shopping with the help of an assistant. They must use all their ingredients according to the chef's rules, finishing their work before time runs out.

The contestants' culinary preferences will come to the fore in the shopping and cooking. Will they put emphasis on the food being healthy or be more concerned about it being tasty to win the man's approval? Maybe the mother knows secret culinary tricks to please him or maybe his tastes have changed and his wife now knows him better.

In order to prevent the man understanding who prepared the dish from the way it is presented, it will be the chef who lays out the food on the plates identically to the other. The man then takes his seat and tucks into the food as his anxious mother and wife both look on, both hoping he prefers their dish.

The man is now in the hot seat, facing a difficult situation where he risks offending either his mother or his wife. Despite the similar look of the two plates, there is the possibility that he recognizes who the cook is from the taste and texture of the food. Will this knowledge, and his thoughts about who might be more upset by being rejected, affect which meal he announces to be the best?

“Rivals in Law” gives a fascinating and amusing insight into important family relationships, potentially revealing strains between mothers and wives but maybe helping clear the air between them. But what everyone wonders is what will happen between them after the man has chosen his favorite dish?
